

# Privacy policy

This page outlines how we collect, maintain and manage any data as part of Dance Mama.

#### TYPES OF DATA COLLECTED

- Among the types of personal data that this application collects, by itself or through third parties, there are: email address, cookies and usage data.
- Complete details on each type of personal data collected are provided in the dedicated sections of this privacy policy or by specific explanation texts displayed prior to the data collection.
- The personal data may be freely provided by the user, or, in case of usage data, collected automatically when using this site

Methods of processing:
